Cindy Rebhan and Micheal Wharton - City of San Jose

Schematics were presented for the renovation of the five park strips between Curie and Snell. Based on a \$35k budget. Bottom line – need to redo based on \$65k budget.

The city will give us \$15k and we are shooting for a \$50k grant from the city. New revisions will include:

- 1. Bringing in more soil to even out beds behind retaining walls.
- 2. Incorporating hardy wall climber that has colorful bloom
- 3. Show the walls as being painted. Check on the paint programs that exist.
- 4. Keep trees spaced as is show the boxes around them and incorporate California indigenous plants/grasses
- 5. Throw in periodically spaced colored pavers
- 6. Check with conservation corp. or whoever else would know on whether or not the wood fences that exist on the 3 park strips were built that way for drainage. If not, schematics should show an extension of the wall.
- 7. Check with the City Forrest about getting the trees free from them so that we can free up the \$7k that is now allocated towards them.
- 9. Do we need to show schematics for all 5-park strips for the application? If so, then those will need to be done as well.

- 10. We need to still know the outcome of putting a doggy bag dispenser on both the two long ones as well as one of the short ones. It should be included in the schematics.
- 11. We need to still know the outcome on whether or not we can post a sign for no parking between 11:00PM and 6:00AM on the two long strips.

Action Item: Jacqueline to stay on top of things with Cindy to ensure that application for CAP grant is met.

Newsletter Update - Danielle
