Initial Meeting on San Jose City General Plan

The initial part of the meeting was a combined session with Silver Leaf Neighborhood Association. (Silver Leaf Neighborhood Association covers the neighborhood near Silver Leaf Park which is south of Blossom Hill Road and between Monterey Highway and 101). The purpose of the joint session was to hear from Stanley Ketchum from the City Planning Department regarding the San Jose General Plan amendment and to gather community input. The San Jose City 2020 General Plan is the long range master plan for the growth of the city. It was last updated in 1994. The city is beginning a process to update the plan. The four phases are:

Phase 1 –Scoping (will begin in May)

Phase 2 – Startup—includes background research, community input and developing a vision.

Phase 3 – Develop & Test an updated City Plan.

Phase 4-Finalize Plan.

Meeting attendees provided a variety of input that was noted by the city planning department participants. Areas of input included the need for adequate police and fire department staff, open space, bike lanes, connecting trails, addressing traffic issues and numerous other items. 1. Approval of March Meeting Minutes

The meeting minutes from the March 8, 2007 Board meeting were approved unanimously subject to revision to correct Andres Quintero's title and to correct the district number mentioned in previous action item 2.

2. Financial Report Status

Rick Mandel sent the Financial Report to the Board via email. The report will be reviewed in the next Board meeting.

3. Open Space and Miracle Mountain

The San Jose City Council approved the proposed Miracle Mountain rezoning subject to the same conditions that were outlined in the STFNA letter to the San Jose Planning Commission. Also, the recommendation to have the Open Space Authority (OSA) purchase the ~28 acre parcel next to the Miracle Mountain 8 acre parcel was included. The parcel ownership/control includes both the San Felippo family and a Mr. Sanchez. John and Matt had discussed with Council member Nancy Pyle the potential for use of the city 20% share of OSA funds for purchase of this adjoining parcel. The OSA has some funds tied up in litigation by a tax payers group so this share may be needed.

John Hesler and Matt Freeman had toured the property with several OSA board members and OSA Director Patrick Congdon. John also went to an OSA Board meeting

to inform them of the City approval of the Miracle Mountain parcel rezoning and the City recommendation to the OSA.

Jerry Strangis, land use consultant for the San Felippo family, is assisting with the possible opportunity for OSA purchase of the 28 acre parcel. The San Felippo family is discussing it with Mr. Sanchez and John will check on the results next week.

4. May General Meeting

The STFNA General meeting will be held at 7pm on Monday May 7. The speaker will be the County Geologist, Jim Baker, who will talk about the geology of the Santa Teresa area. The agenda will include

6. Trail update

John and Matt participated with city Parks Dept representatives and consultant for a walkdown of the trail. The consultants have been reviewing the previous trail feasibility study but John and Matt pointed out that the study was flawed and previous assumptions should be questioned. It is proposed that the STFNA emphasize the possibility of opening one or two sections of the trail rather than having the entire trail project moved forward at one time. An area of the trail that is already heavily used is the section from Snell to Cahalan. The Board will review the trail maps at the next Board meeting.

8. Other

Santa Teresa Apartment Fire

Ash Kalra had previously reported that he had noted the recent Santa Teresa apartment fire and has set up a Victim's fund with Bank of the West to assist those that lost their homes. Many of the victims were elderly people and low income residents. The Red Cross will assist Ash in coordinating distribution of the additional funds to the victims. A fundraiser will be held on Saturday May 5 1-4pm with a Cinco de Mayo theme. It will take place in the parking lot of St. Julies Billiart Parish.

Next STFNA Board Meeting

The next Board meeting will be held on the third Thursday in May rather than the second Thursday. It is proposed that we have an overview of the status and EIR process on Coyote Valley. The EIR is due to be released within the next several weeks. It is important that we take the opportunity to review and comment on it. It is possible that we would combine with the Silver Leaf Neighborhood Association for this discussion. A video about the Coyote Valley Project called Two Rivers Run through It has been created by an elementary school. Ash recommends it. He will let the board know where to get a copy of this item.

We had also identified that we should look at the Coyote Alamitos canal trail maps at the next Board meeting.
