Report on OSA Board Meeting

STFNA Board members John Hesler, Lynne Paulson and Rick Mandel attended the Open Space Authority (OSA) Board meeting this evening. John Hesler presented comments on STFNA concern regarding the San Jose City Council recommendation that the OSA consider purchase of the ~28 acre parcel of land in the Santa Teresa foothills that is adjacent to the Miracle Mt. parcel that recently obtained rezoning approval. He provided background information and urged the Board to consider the matter. The OSA Board then placed this item on the agenda for their Dec. 13 meeting. After our participation in the meeting, we established contact with Dave Poeschel who is a member of the OSA Citizen's Advisory Committee.

Lynne will send the contact information to the board (Action Item 1). John Hesler will coordinate with Patrick Congdon, OSA General Manager, to find out how to participate in the presentation and discussion at the Dec. 13 meeting. John will ask Patrick about options for STFNA Board presentations and then help identify the plans for STFNA board members to speak on various aspects of the proposal including the advantages of the trail, protection of wildlife corridor, and protection against hillside development, etc. (Action Item 2).

John will also obtain the OSA Staff report on the agenda item prior to the Dec. 13 meeting so that the STFNA Board can review it in preparation for the meeting (Action Item 3).

Approval of Meeting Minutes

Approval of the meeting minutes from the October 25 General Association meeting was postponed pending receipt of comments from Matt Freeman Approval of the October 11 STFNA Board meeting minutes was postponed in order to obtain an updated status on the previous open action items.

Financial Report

Treasurer Rick Mandel discussed the financial report; however, he is still updating it and will provide the updated version later. This will include details on how much of the STFNA funds are allocated to the Curie Drive project. Rick is in the process of confirming the financial status of the Curie Drive project including application, agreement, original deposits. Rick will contact other board members on this if required including John, Danielle and previous board member Ron White (Action Item 4). The information will be used for a report to the agency for closeout of the project. Jacqueline is applying to use remaining funds for new project aspects. Matt will send Rick information on the PO Box Rental charges (Action Item 5).

School Community Committee

STFNA is providing representation on the Santa Teresa High School Citizens Advisory Committee. STFNA supports reasonable use of the school fields. Rick Mandel attended the last meeting. At that meeting, lights on the field were discussed as an issue.

Review of Designation as 501c3 Organization

In order to determine if STFNA should register as an organization with 501c3 designation (non profit status) according to the US Internal Revenue Code, Ash Kalra will coordinate with Mike Bosworth and Mike Boulland (Friends of Santa Teresa Park) to prepare a presentation on the pros and cons for the January 2008 STFNA Board meeting (Action Item 6).

Engineering Study on the Trail

An engineering study regarding the proposed Coyote Alamitos Canal trail options has been completed by a consultant for the city as of July 31. John Hesler is obtaining a copy for the STFNA Board (Action Item 7).

UNSCC Conference

The United Neighborhoods of Santa Clara County is holding its 2007 Conference on Saturday, Nov. 17, 2007. STFNA Board members should have received notices about this from UNSCC.

Housing Commission

Andres Quintero reported hat there are 4 vacancies on the Housing Commission. He will send the notice to the STFNA Board so that we have more information on the scope and purpose of this commission (Action Item 8).

Best Update

Dave Smith provided an update on the project to Beautify Everything Santa Teresa (BEST). He has 2 more sponsors. He would like to identify musicians to play at the next BEST event next year. He needs assistance in getting the right contact at Santa Teresa High School on this. Rick Mandel will send Dave Smith contact information on the Band Booster leader (Action Item 9). Another option for a contact person would be Mike Reed, the activities director.
