- Update on effort to improve park-strip landscaping of city-owned lots along Curie.

## HILLSIDE DEVELOPMENT UPDATE

Earlier this year, the owner of an 8-acre parcel located at the end of Miracle Mountain Drive applied to the City for a zoning change to allow the construction of a single-family residence. This parcel extends from the end of Miracle Mountain to the area behind homes on Foothill. The Association has not taken a position on the proposal because the applicant

has not yet submitted a plan. Because the site is located on the front side of the Santa Teresa Foothills, potential concerns will include visual, geologic, and biologic impacts. Association board members hope to meet with the applicant in the near future so that a project that meets the needs of both the community and applicant can be satisfied.

# **Neighborhood Beautification**

### **Parkstrips Update**

The neighborhood association is still actively working to beautify the parkstrips in front of the city owned lots along Curie. We worked with the city's Parks & Recreation Department to come up with an estimate of costs for the project and then applied to the Community Action and Pride (CAP) program through the city for funding. Unfortunately, this program was underfunded, and with scarce funds our application was not one of the ones selected during their last round of funding. We are appealing this decision, have worked with the Parks & Rec Department to revise the budget, and will apply again during the program's next round of funding.

### Trail Access to Santa Teresa County Park

Santa Teresa County Park is well known for it's great views, trails for hiking and biking, and large picnic grounds. Since it is on the Southeast border of our neighborhood, it is an easy destination for many of our members, but It has been a challenge to access from the neighborhood without driving to the top.

In order to provide legal access, the County Parks Department is planning to put in a new trail that will start on county owned land at or near Curie Drive and San Ignacio, go up the hill above the canal, and run behind the Mounted Ranger Unit that was opened last year.

As part of this effort, the County Parks Department
