- If I already have solar on my house, what are my options?


We have good news! The Director of San Jose Clean Energy, Lori Mitchell, will be our featured speaker at the May 22nd general meeting. She will explain the program and answer your questions.

With more than 20 years of experience in the renewable energy and utility industry, Lori Mitchell comes to San Jose from her most recent employment at the San Francisco Public Utilities Commission (SFPUC). Her career at SFPUC reflects a succession of progressively responsible positions, including Manager of Renewable Energy, Power Supply Manager and, most recently, Acting Director of Energy Infrastructure.

<u>Background:</u> In February 2019, San Jose Clean Energy (SJCE) became a new electricity generation provider, bringing San Jose residents and businesses cleaner energy at lower rates than PG&E. SJCE is one of 19 Community Choice Energy agencies in California, serving over 8 million residents and businesses.

Since 2010, these agencies have saved customers millions and cut greenhouse gas emissions drastically.

Planning For High Speed Rail In South San Jose

Despite rumors to the contrary, plans for High Speed Rail (HSR) are moving forward. Construction in the Central Valley is underway and designs for HSR through San Jose are being evaluated. Did you know that the

trains will run along Monterey Road in South San Jose? Designs being considered include an elevated viaduct in the median of Monterey Road and an at-grade alignment in the Union Pacific Railroad corridor.

Members of the Association's Board of Directors are working with other neighborhood leaders in South San Jose to lobby the California High Speed Rail Authority for a design that minimizes impacts to our community. Specifically, we are concerned about HSR's potential acquisition of residences and businesses, as well as safety, visual, and noise impacts. We believe that leaving the Skyway Drive, Branham Lane, and Chynoweth Avenue at-grade rail crossings in their existing configurations is unacceptable because that will result in significant safety and traffic impacts due to the increase in crossings by HSR, Caltrain, Amtrak, and freight trains. We believe that a design that places HSR in a trench is one that will address these concerns.

As the HSR planning process moves forward, we will keep you informed.

Santa Clara Valley Open Space Authority (OSA) Update

OSA conserves the natural environment, supports agriculture, and connects people to nature, by protecting open spaces, natural areas, and working farms and ranches for future generations. We envision the Santa Clara Valley and its surrounding hillsides as a beautiful place where a vibrant network of interconnected open spaces, trails, wildlife habitats, and thriving agricultural lands enrich our region's cities and make it an exceptional and healthy place to live, work, learn, and play.

The Authority serves over 1.4 million residents – we embrace their diversity and strive to provide access to nature for all of our constituents. We've worked to protect over 60 acres in the Santa Teresa Foothills while also providing over \$1.3M in urban open space grants to projects like Albertson Parkway and Santa Teresa Historic Park. We continue to work with land owners, the City of San Jose, and Santa Clara County Parks to protect additional open space in the Santa Teresa Foothills and continue to work towards establishing a public trail.
